## **Sun Gallery Summer Art Day Camp Discipline Policy**

(Parent or Guardian, Please read over these rules)

Sun Gallery strives to provide each student with a positive, engaging artistic experience. We work hard to create a positive environment for teaching, learning, and summertime fun. We will provide organized outdoor activities for scheduled breaks. We expect our students to respect other campers, volunteers, gallery staff and teachers.

**Please review these rules with your child before he/she/they starts Art Camp:**

1. **Respect The Gallery Rules:** No running or playing inside the gallery space. No touching the artwork in the exhibit.
2. **Stay in supervised areas:** (The hill in the courtyard and the areas behind the buildings are off limits. Stay within the fenced area).
3. **Respect each other:** No hitting, putdowns or bullying. We strive to create a positive space for creativity and self-expression and do not tolerate bullying.
4. **Respect the gallery & studio:** Students will be responsible for helping to clean up their own areas on a daily basis. Students who violate our discipline policy will first receive a verbal warning. If rules and warnings are ignored still, possible outcomes are phone calls to the student's parents and being sent home early from camp.
